WE, the undersigned majority of the Directors of the FEHILIPPINS BANK OF COMMUNICATIONS and the Chairman and the Acting Secretary of the regular annual meeting of the shareholders of said corporation, duly held at the principal office of the corporation on the 7th day of March, 1967 at four o'clock, P.M., do HERESY CERTIFY:

- a) That the authorized capital stock of the said PHILIPPINE BANK OF COMMUNICATIONS was duly and regularly increased from P10,000,000.00 to P30,000,000.00 as hereinafter stated, at the regular annual shareholders meeting aforesaid, and that the requirements of Section 17 of Act 1459 as amended, otherwise known as the Philippine Corporation Law, have been complied with.
